4. Close the container with the trigger and shake smoothly.

5. Mix 75 c.c. of product diluted into 8 l. of water.

6. Clean the floor with a mop. No rinse needed.

7. As a general cleaner: apply the product diluted directly on a cloth.

8. Clean the surface and dry. No rinse needed.
