Description:

Shampoo for rotating machines that penetrates deeply into the fibres, crystallizing dirtiness and absorbing it completely. Takes care of colours and of the surface to be treated. Fast dry.

Key Properties:

Cleans deeply moquettes, carpets and textile pavements in general. Revives colours and softens treated surface. For manual use or with rotating machine.

Use Instructions:

Machine use: Vacuum the surface to be treated to remove dust. Dilute with water at 1:10 proportion for strong dirtiness and 1:20 for light dirtiness. No rinsing needed. Once dry, vacuum to remove rests.

Manual use: Vacuum dirtiness. Dilute with water, 1:10, and shake. Apply foam with a sponge or brush in areas of 1-2 m², and rub. Let dry and vacuum.
