### SECTION 4: FIRST AID MEASURES

#### 4.1 Description of first aid measures:

Request medical assistance immediately, showing the SDS of this product.

**By inhalation:**

This product is not classified as hazardous through inhalation. However, in case of intoxication symptoms it is recommended to remove the person affected from the area of exposure, provide clean air and keep at rest. Request medical attention if symptoms persist.

**By skin contact:**

Remove contaminated clothing and footwear, rinse skin or shower the person affected if appropriate with plenty of cold water and neutral soap. In serious cases see a doctor. If the product causes burns or freezing, clothing should not be removed as this could worsen the injury caused if it is stuck to the skin. If blisters form on the skin, these should never be burst as this will increase the risk of infection.

**By eye contact:**

Rinse eyes thoroughly with lukewarm water for at least 15 minutes. Do not allow the person affected to rub or close their eyes. If the injured person uses contact lenses, these should be removed unless they are stuck to the eyes, in which case this could cause further damage. By contact with the eyes:

Flush eyes with plenty of water at room temperature for at least 15 minutes. Prevent the affected person from rubbing or closing their eyes. In the event that the injured person wears contact lenses, they must be removed as long as they are not stuck to the eyes, otherwise additional damage could occur. In all cases, after washing, you should go to the doctor

By ingestion/aspiration:

Require immediate medical assistance. Do not induce vomiting, because its expulsion from the stomach can cause damage to the mucosa of the upper digestive tract, and its aspiration, to the respiratory tract. Rinse mouth and throat, as there is a possibility that they may have been affected by ingestion.
