Remove contact lenses if present and easy to do – continue rinsing. In case of fire: use for extinction ABC powder extinguisher. Store in a well ventilated place. Contains: 2-(4-tert-Butylbenzyl) propionaldehyde; Amyl cinnamal; Citronellol; d-Limonen; Eugenol; 2,4-dimethylcyclohex-3-ene-1-carbaldehyde. May produce an allergic reaction. FOR PROFESSIONAL USE.
