#### Description:

Product made on the basis of surfactants and amines for floor stripping of successive wax applications. Due to its composition and alkali character, it acts not only as a stripper, but as a powerful cleaner with degreasing action.

## **Key Properties:**

Product, especially conceived for the removal of old layers of wax, before coating the floor with a new treatment.

#### **Use Instructions:**

Dilute 11 of product per each 101 of water.

Apply the mixture to the floor with a mop and leave it for a few minutes. Rinse thoroughly with clean water until the removal of foam and wax rests. It is recommended to do it on small surfaces (2 to 4  $m^2$ ).

It can also be done with a rotating machine, using abrasive discs (brown or black); this way, the process will be shorter and more effective.
